Mission Statement

Course Description

An advanced course giving consideration to text-critical, grammatical, syntactical, literary, and historical issues through text analysis in a variety of genres. The course willemphasize sound hermeneutical principles for discovering the meaning of the text and for applying the text in teaching and preaching. Students may repeat the course for non-reduplicating books. Prerequisites: NTGK5351 Greek 1; and NTGK5352 Greek 2.

Student Learning Outcomes

- 1. Students should understand the state of research related to the PastoralEpistles
- 2. Students should gain an increased appreciation for the relevance of the exegetical study of the Pastoral Epistles
- 3. Students should acquire the ability to apply their understanding of the context and text of the Pastoral Epistles to a sound interpretation of the text

Textbooks

Yarborough, Robert W. *The Letters to Timothy and Titus*. The Pillar New Testament Commentary. Grand Rapids: Eerdmans, 2018.

Students will choose one additional commentary from the selected bibliography(see below).

Course Teaching Methodology

The course will involve the following methodologies:

- Class sessions will consist of translation and syntax, discussion of textbook reading, and exegesis of selected passages. Students should be prepared to actively engage in class discussions.
- Class preparation will consist of textbook readings according to the syllabus schedule. Students should be prepared to translate from the assigned passages for that class session.

Course Requirements

- Critical Introduction Assignment- Each student will write a 1,500-2,000 word critical introduction to 1 Timothy including authorship, audience, date, occasion,opponents, and outline of the text. The assignment should include reading fromoutside of the textbooks. Students will be expected to discuss their critical introduction assignments on the first day of class. The Critical Introduction assignments are due before the first class session on **June 26** and are worth 10% of the final grade.
- 2. *Reading* Students will read the appropriate sections of the assigned commentaries before coming to class. Students will be required to submit a reading statement by **July 7th**. The reading requirement is worth 10% of the finalgrade.
- 3. *Class Participation* Students are expected to actively engage in class, including translating when called on, discussing required reading, participating in class discussion, etc. Class participation is worth 10% of the final grade.
- 4. *Vocabulary Quiz* Students will be expected to be familiar with the vocabulary of 1 Timothy by the first day of class. Students will take a vocabulary quiz on the words used in 1 Timothy on the last day of class. This vocabulary quiz is worth 10% of the final grade.
- 5. *Translation and Syntax* Students will submit a translation of 1 Timothy with extensive notes on their translation choices and the syntax of the passage. The translation and syntax assignment will be due on **July 14th** and is worth 30% of the final grade.
- 6. Exegesis Assignment- Students will complete an exegesis assignment on a selected passage in 1 Timothy. The assignment will address the genre of the passage, the historical-cultural context, and the literary context of the passage. It will include a verse-by-verse exegesis of the passage, as well as a phrasing of the passage with notes, and a section on the theology/application of the passage. This assignment should be 2,000-3,000 words. The Exegesis Assignment is due on July 28th and is worth 30% of the final grade.

Evaluation of Grade

The student's grade will be computed as follows:

10% - Critical Introduction
10% - Class Participation
10% - Reading
10% - Vocabulary Quiz
30% - Translation and Syntax
30% - Exegesis Assignment
