Course Description

This Seminar is designed to involve students in the analysis and investigation of the historical context or relevant theological issues pertinent to Baptist life in general and the Southern Baptist Convention in particular. Students will encounter and engage significant historical, theological, and/or ministerial issues through readings, papers, and class discussions. The course is designed to promote the integration of history and/or theology in Baptist ministry and church life. Various topics may be addressed in the seminar at different times. Can also be taken as THTH8306.

Topics for this Semester

This seminar we will explore how Baptists view the ordinances in light of the emerging sacramentalist movement. We will also examine the understanding of congregational polity in light of expanding congregational structures, such as multi-campus, multi-staff, and elder-led.

- Understand the varied perspectives in Baptist life regarding the doctrine(s) addressed.
- Be able to articulate a well-informed Biblically-based and confessionally Baptist description of the doctrine(s) addressed.
- Achieve greater appreciation for Baptist beliefs about the doctrine(s) addressed.
- Be able to communicate the various aspects of the doctrine(s) addressed through a sermon or conversation

Course Requirements

- **A. Text Reviews:** Each student will write a review of **EACH** of the Required Texts. The reviews will be written as though for an academic magazine or journal. No title page is required; please provide the name of the student and assignment as well as the date at the top of each submission. It should:
 - 1) Bibliographic entry,
 - 2) Biography of the author(s) (a few sentences on dates, degrees, theological tradition, academic posts held, research interests, and significant works),
 - 3) Brief summary of the contents,
 - 4) Evaluation of the work's strengths and weaknesses,
 - 5) Compare and contrast the texts with each other.

All quotations and direct references to sections in the book should be indicated by page numbers within parentheses. Citations or paraphrases from other sources should be noted and documented using either footnotes or endnotes. Reviews should be 3-5 pages in length, single-spaced. Each review is worth 50 points. **Due July 15, 2025**.

B. Book Review: Each student will write a review of a book from the list below that the student has not already read. No duplications will be allowed. Sign up for your book on Canvas. Books will be assigned on a first come first served basis. The review will follow the above Text Review guidelines 1-4. Reviews should be 2-3 pages in length, single-spaced. Students will present their review during class as a basis for discussion. The review and presentation are worth 40 points. Review presentations will begin on the first day of class, July 15, 2025.

- C. Research Paper: Each student will write a research paper on a topic related to the class. Topics must be approved by the professor. The paper must be double spaced and follow Turabian, eighth edition, for style. However, do not use chapters to separate sections of your paper (chapters require a new page for each new chapter and the project is not long enough to justify this). Use section headings instead. The appendix should come before the bibliography and be single spaced. The text of your paper (not counting table of contents, appendix, or bibliography) should be 12-15 pages in length (no more, no less). Use 5 10 sources with a minimum of three (3) books (do not use only Internet sources). A late paper will be assessed an initial 10 point penalty. Each calendar day after the due date (excluding Sunday) an additional 10 point penalty will be assessed. Projects will be graded on clear organization, spelling, and grammar as well as content. Examples of Turabian form will be available in Canvas. Research papers are worth 100 points and are due August 15, 2025.
