ReDOC office and other NOBTS staff are a team working on conversion of PowerCampus (SelfServe) to the new Campus Nexus Student software system. Because we will be working in the ITC October 1-3, the dissertation submission deadline has been pushed to **October 4**.

However, *PhD graduates still need to apply online for graduation no later than October 1.* This deadline is nonnegotiable!

Also, ProQuest has changed their document submission procedure (see p. 3). Students with approved prospectuses should receive an e-mail regarding fees.

### Process for Human Subjects Research

In 1974 Congress signed the National Research Act (Pub. L. 93-348), which created the National Commission for the Protection of Human Subjects of Biomedical and Behavioral Research. This commission sets policy for ethical treatment and protection of human subjects in the areas of respect for persons, beneficence, and justice.

As a subcommittee of the Research Doctoral Oversight Committee, the Institutional Review Board reviews prospectuses for protection of human subjects in the informed consent and research procedures. Prospectuses involving human participants in any way must be submitted to redocsec@nobts.edu one month before the ReDOC meeting at which the prospectus will be reviewed (see details below).

For more information on research with human subjects, see the Belmont Report. In addition, the National Institutes of Health website offers training and resources.

An IRB request and a pdf of a prospectus for research using human subjects must be submitted to the guidance committee chair, who must forward them to redocsec@ nobts.edu, indicating permission to proceed, no later than

The following are the ReDOC one month prior to the meeting at which the prospectus will be considered. See the Program Materials page for the form and details.

> A prospectus to be considered by ReDOC must be reviewed by your guidance committee and 11 copies (double-sided printing is allowed) submitted through your chairperson to the Office of Research Doctoral Programs no later than one week before the scheduled ReDOC meeting. Prospectuses for research involving human subjects must be received one month before the meeting.


Likewise, matters such as directed study proposals and requests to take courses at other institutions must be submitted one week before the ReDOC meeting at which they will be considered. Also e-mail a **pdf** of the prospectus or directed study proposal to phd@nobts.edu. Do submit a hard copy of the directed study approval page.

If your research involves human subjects, you must go through the Institutional Review Board approval process. Your guidance committee cannot approve your prospectus until (1) the IRB assesses the risk to and protection of the participants; (2) you submit your revised prospectus, consent form, and IRB request; and (3) the IRB approves your treatment of human subjects as reflected in these documents. You cannot contact study participants before approval of both the IRB and your guidance committee. IRB approval is valid for two vears.

The maximum length for the prospectus is 30 pages of text plus the selected bibliography. **Documents** with text longer than 30 pages will not be accepted.

**NOTE:** If you think your guidance committee approved your prospectus but you have not seen it in the ReDOC News, contact the ReDOC office. You cannot contact human subjects before approval.

### New ProQuest Dissertation Process



Traditional publishing is free, and the copyright fee has been reduced to \$55. Personal bound copies of the dissertation will be \$48 + tax and shipping.



The Southern Association of Colleges and Schools Commission on Colleges is offering a travel grant for students who would like to attend their Annual Meeting in Houston, TX, December 7-10, 2019. Becoming familiar with the accreditation process is helpful for students hoping to teach at the college or seminary level because accreditation assessment is a standard part of being on faculty.

The deadline for completing a <u>travel grant application</u> is **September 23, 2019**. See the <u>SACSCOC website</u> for details.

In the summer we learned that ProQuest no longer accepts submission of hard copies of dissertations. With the new electronic submission, the left margin is required to be 1". ProQuest's software will format documents for binding, so students no longer need to purchase cotton paper for final copies if they order bound volumes from ProQuest.

By the October 4 dissertation submission deadline for December 2019 graduation, four plain-paper copies in separate boxes or clips must be submitted to the ReDOC office as usual. Payment of fees for library copies (\$120) and a non-NOBTS external reader (if one has been pre-approved) will be required at that time. The diploma fee is paid online with the graduation application, which is due by October 1.

Students will pay dissertation and copyright fees directly on the ProQuest site when the ReDOC office gives them permission to upload the final documents following approval by the guidance committee chair and the ReDOC staff.







### 2019-2020 Wabash Center Teaching Seminars for Doctoral Students

Over the next few years, Wabash Center Teaching Seminars for Doctoral Students will be held in U.S. cities with significant numbers of doctoral programs in theological and religious studies. These seminars will feature conversations around teaching facilitated by two Wabash consultants. The purpose of the seminars is to contribute to the formation of future teachers by guiding doctoral students in conversations about teaching, both in general and in specifics including

- Critically reflective teaching
- Design of learning experiences
- Teaching contexts
- Issues of diversity in the classroom

The seminars will also provide an opportunity to acquaint students with the Wabash Center and its resources so they can take advantage of the Wabash Center's fuller programming when they have teaching appointments. In addition, doctoral students will discover ways to build networks of support and conversation across institutions.
